In consideration of the expenses of the Oncology Nursing Society (hereinafter referred to as ONS) in editing and publishing and other good and valuable consideration, the undersigned hereby agrees to the following:

1. The undersigned (hereafter referred to as the "Author") has prepared an article or other written work tentatively titled:

(hereinafter referred to as the "Article") for consideration by ONS for publication in the *Oncology Nursing Forum* (hereinafter referred to as *ONF*).

2. **A. Copyright Transfer:** Author hereby understands and agrees that *ONF* is published by ONS and the copyright(s) in each of its issues is and shall be exclusively owned by ONS. Author further understands and agrees that once the Article is submitted to ONS for consideration for publication in *ONF*, all rights, title, and interest, including copyrights, in and to his or her Article shall be held exclusively by ONS. Accordingly, Author hereby irrevocably grants, assigns, and transfers exclusively to ONS all rights, title, and interest in and to the Article except as provided in 2B, below, including the full and exclusive rights comprised in the copyright in the Article during the full term of the copyright and any extensions thereof, including but not limited to the right, by itself or with others, throughout the world, to print, reproduce, publish, republish, reprint, and distribute the Article, in whole or in part in print and online, or in any media in existence now or that may be developed in the future. ONS is the exclusive grantor of permission, except as provided in 2B below, to others to use portions of articles or other written works published in *ONF*.

B. Author Rights: ONS hereby grants to the Author the nonexclusive right to (i) reproduce, distribute, publicly perform, and publicly display the Article in the course of nonprofit teaching and research activities; (ii) post the Article on his or her personal website or that of the Author's employer, provided any such site has commercially reasonable safeguards in place to protect against unauthorized copying of content; and (iii) prepare, reproduce, distribute, publicly perform and publicly display derivative works from the Article, provided that, with respect to (i), (ii), and (iii) above, *ONF* is cited as the source of first publication of the Article, and ONS is clearly indicated as the owner of the copyrights in the Article.

The Article is subject to editorial review and, if not published, will be returned to the undersigned and all rights assigned in paragraph 2 hereof shall automatically revert to the undersigned. Author further agrees to the use of his or her name, pseudonym, biography, and/or photograph in publicizing, advertising, and promoting the Article and *ONF*.
