This bill recently passed the House of Representatives by a unanimous vote.
- **S. 518, the Lymphedema Treatment Act** would require Medicare to cover compression garments and other supplies to treat painful swelling from lymphedema, which can be caused from cancer.

Additionally, ONS seeks Senate sponsorship and support for companion legislation to these bipartisan House bills:

- **S. 741, the Cancer Drug Parity Act** would ensure that patient cost-sharing for **oral** anti-cancer drugs is no less favorable than patient cost-sharing for anti-cancer drugs that are injected or administered intravenously and already covered by private group or individual health insurance plans.
- **S. 1048, the Preventing Opportunities for Teen E-Cigarette and Tobacco Addiction (PROTECT)** would authorize \$100 million in CDC funding for five years to address the dramatic rise in youth tobacco use of e-cigarettes.
